

## CASTLEMAN ACADEMY TRUST REGISTER OF PEOPLE WITH SIGNIFICANT CONTROL (PSC)

A PSC is an individual who meets one or more of the following conditions:-

- Owns more than 25% of the Academy Trust's voting rights
- Has the right to appoint or remove a majority of the board of directors
- Has significant influence or control over the Academy Trust
- Has significant influence or control over a trust or firm (in the case of shares held by trustees or a trust or by members of a partnership)
